**SUBJECT: CRIMINAL ALLEGATIONS REGARDING THE COMMISSION OF FRAUD AND VIOLATION OF FEDERAL LAW AND THE U.S. CONSTITUTION**

I, Frederick Michael Traweek, the complainant in this case, state that the following is true to the best of my knowledge and belief.

**Allegations and Supporting Facts**

1. Obama has violated his oath of office by intentionally ignoring and/or avoiding his sworn duty to preserve and defend the Constitution of the United States; AND
2. Obama violated the Posse Comitatus Act; AND
3. Obama violated the War Powers Resolution; AND
4. Obama violated the Constitution by not securing our borders and by authorizing broad prosecutorial discretion in pursuing charges against illegal aliens; AND
5. Obama violated Federal Law by intentionally directing taxpayer funds to influence the outcome of an election in Kenya; AND
6. Obama violated Section 9 of the Constitution by accepting the chair of the UN Security Council; AND
7. Obama violated Federal law restricting the export of guns without a license. As a direct result of his authorization, two Federal agents were murdered with the guns he caused to be exported to known criminals. He is therefore charged with being an accomplice in the murder of two Federal agents; AND
8. Obama committed and continues to commit fraud by claiming to be eligible to run for and hold the office of POTUS in accord with the US Constitution despite personal knowledge that he is not now nor has he ever been a “natural born citizen” as required by the US Constitution;

9. Obama has committed Treason to the United States of America.

### **Statement of Probable Cause**

The Complainant states that these facts establish probable cause that the following crime(s) have occurred:

1. Violation of oath of office.
2. Violation of the Posse Comitatus Act.
3. Violation of the War Powers Resolution.
4. Violation of the Constitution by refusing to secure our borders.
5. Violating U.S. law prohibiting using taxpayer funds to lobby either for or against abortion.
6. Violation of Article 9 of the US Constitution by assuming the chair of the UN Security council.
7. Illegally exported guns directly to known criminals which led to the violation of the civil rights of two Federal agents leading to their murder.
8. Committed fraud by claiming to be a “natural born citizen”.
9. Committed Treason by knowingly and intentionally running for and accepting the office of POTUS despite the fact the he knew he was not a natural born citizen but the subject of foreign nation.

FURTHERMORE, I hereby demand that Obama be held to his sworn Oath of Office in which he is required to protect and defend the US Constitution; AND

FURTHERMORE, I hereby demand that you comply with your obligations under law, and by virtue of your own oath to defend the US Constitution by charging Obama with:

the aforementioned violations of law, and  
violation of his sworn Oath to defend the US constitution, and  
of fraud against the US Constitution, the Congress, the US Supreme Court, and  
against the People of these United States of America, and  
violating the civil rights of two murdered Federal Agents, and  
as being an accomplice to the murder of two Federal agents, and  
any additional charges prescribed by law.

LASTLY, that these charges be presented against Obama immediately as he presents a clear and present danger to the existence of the US Constitution, and through it, the existence of these United States of America.
